### **CCKids Honors Staff Who Go the Extra Mile**

**St. Lucie County** – Communities Connected for Kids congratulates Rebecca Hull and Melanie Kranker for winning this quarter's Going the Extra Mile – or GEM – Award.

Hull and Kranker won the award, an honor given to



staff and caregivers for excellence in service to children and families in Okeechobee and the Treasure Coast, for the period spanning January through March.

Hull, a case manager in Martin County, received the award in the Emerald Division, which covers case-management staff. She was nominated by her supervisor, Mary Altiery, for her work in reunifying three siblings with their grandmother. The children were living in different homes and all

moving toward separate adoptions.

"The grandmother is lower income, and we knew that it would take a lot of assistance and support to make this placement happen, especially due to the fact that the children have some significant behavioral issues," Altiery said.

"Rebecca went above and beyond to assist this grandmother and these children to ensure that they had everything they needed to be successful.

"She reached out to our community partners to request bedding for the children and a new kitchen table as the grandmother only had a very small table in her home, and Rebecca understood the importance of family meals. When Rebecca placed the children in the home it was December, and we were in a cold snap in Florida, so she used her own money went out bought the kids gloves hats as well as groceries for the home so that they would be comfortable.

"The grandmother is now in the process of adopting her grandchildren, their behaviors have improved immensely, and they are finally all together."



Kranker, CCKids' Behavioral Health Supervisor, received her GEM award in the Ruby Division, which recognizes the work of administrative and program staff. She was nominated three time, by two co-workers and her supervisor, Josie Kirchner.

"Melanie is always going the extra mile, leading her team by example," Kirchner said. "She can be counted on to volunteer when the call is made without a second thought and has become part of the usual group of

employees who can be relied upon to do whatever is needed to ensure a successful event."

For example, Kranker was part of the planning committee for the recent Prevention Expo, one of the company's best attended events in recent history. She also has helped with parades, volunteer recruitment, hurricane relief and, most recently, secured an important donation to ensure that children waiting in offices have snacks to tide them over until mealtime.

CCKids' Board of Directors will recognize Hull and Kranker during its June Board

meeting. Each employee will receive a \$100 bonus and a plaque.

## **Who Needs Braces?**

The answer is, "a lot of people", especially children in the dependency system who often go their entire lives without routine dental services.

So this week, I'll share some information about the My Healthy Child Grant funding program that can assist in the cost of orthodontia care.

Sunshine Health and Community Based Care Integrated Health, partners in the Sunshine Health Child Welfare Specialty Plan (CWSP) help manage this privately-funded grant program that is intended to address gaps in healthcare available to post-adopt youth and youth in foster care. Specifically, these are services that are not covered by Medicaid or determined to be not medically necessary.

This grant fund covers costs associated with *orthodontic care* that was deemed *not medically necessary* by Medicaid (i.e. orthodontic services for cosmetic purposes).

#### WHO IS ELIGIBLE?

- Children or youth requiring orthodontic services must be *currently enrolled* in the Florida Medicaid Sunshine Health Child Welfare Specialty Plan (CWSP). If you are not sure what plan you have, you can call Sunshine member services at 1-855-463-4100 or ask your DCM-Dependency Case Manager.
- Orthodontic services must have been *recommended* by the enrollee's dental provider.
- Request for orthodontic services must have been submitted to a Medicaid dental plan with all of the required documentation within the last twelve months and *denied based on medical necessity* criteria.
- An Orthodontist must have provided a *written cost estimate* for orthodontic services.

If you have a child who may qualify for this grant, please let your case manager know and/or email me at <u>lisa.mcbride@cckids.net</u>.

Summertime is a great time to meet with an orthodontist, get the necessary exams and forms submitted to your Medicaid dental plan with denial letter returned so your packet is ready to go when the fall grant is released.
